VERIFICATION STATEMENT ANNEX

EMICERT has been contracted by Elysée Irrigation Ltd (hereinafter referred to as "the Company"), for the verification of Greenhouse Gas emissions in accordance with **ISO 14064-1:2018** as provided by the Company, in the GHG Assertion in the form of GHG report covering GHG emissions of the year 2023 (01/01/2023-31/12/2023).

1. Roles and responsibilities

The management of the Company is responsible for the organization's GHG information system, the development and maintenance of records and reporting procedures in accordance with that system, including the calculation and determination of GHG emissions information and the reported GHG emissions.

It is EMICERT's responsibility to express an independent GHG verification opinion on the GHG emissions as provided in the GHG Assertion for the year 2023.

EMICERT conducted a third party verification of the provided GHG assertion against the principles of ISO 14064-1:2018 and ISO 14064-3:2019 for the year 2023. The verification was based on the verification scope, objectives and criteria as agreed between the Company and EMICERT.

2. Level of Assurance

The level of assurance agreed is that of **reasonable assurance**. This means that the nature and extent of the verification activities have been designed to provide a high but not absolute level of assurance on historical data and information.

3. Scope

The Company has commissioned an independent verification by EMICERT of reported GHG emissions of the Company, for manufacture and supply piping and irrigation systems for water supply, irrigation, sewerage and energy, to establish conformance with ISO 14064 principles within the scope of the verification as outlined below.

This engagement covers verification of emission from anthropogenic sources of greenhouse gases included within the organization's boundary and is based on ISO 14064-1:2018.

4. Objective

The purposes of this verification exercise are, by review of objective evidence, to independently review:

- Whether the GHG emission are as declared by the organization's GHG assertion
- The data reported are accurate, complete, consistent, transparent and free of material error or omission.

5. Criteria

Criteria against which the verification assessment is undertaken are the principles of ISO 14064-1:2018 and ISO 14064-3:2019.

6. Materiality

The materiality level of the verification was agreed to 5%, based on the needs of the intended use of the GHG Assertion.

7. Confidentiality

The reports and attachments may contain relevantly confidential information of the Company. In addition to being submitted as governmental application or certification documents, the reports and attachments are not allowed to be edited, duplicated, or published without the Company's agreement in written form.

8. Conclusion

The Company provided the GHG assertion based on the requirements of ISO 14064-1:2018. The GHG information for manufacture and supply piping and irrigation systems for water supply, irrigation, sewerage and energy, for the year 2023 disclosing emissions of 19,006 tonnes of CO₂ equivalent are verified by EMICERT to a reasonable level of assurance, consistent with the agreed verification scope, objectives and criteria.
